The Parties understand that this document is in no way legally binding and/or governed by English law and each Party confirms that they have the right and the capacity to enter into this agreement. The Dragon Pact is governed by the law of 'no-take-backsies'.

## **The Defined Program**

### **House of the Dragon Season 2**

This agreement only covers the Program. Future agreements must be put in place to cover further series, mini-series or spin offs.

#### 1. Terms

- 1.1 By signing the Dragon Pact, the Parties agree that they will not view any episode without the other Party. They also agree not to consume any featurettes, accompanying podcasts, "behind the scenes" content or ANY other materials related to details of the program that are unknown to the other Party at that time.
- 1.2 Any intentional or unintentional sharing of "spoilers" (important details of the general plot or characters) by either Party will also be treated as a violation of this contract.
- 1.3 If either Party is found to be in violation of these terms, by any act, omission, or by consensus of their peers, that Party will be subject to the penalty or penalties detailed below.
- 1.4 For the purposes of 1.3, the defences of 'omg I completely forgot' and 'it was an accident I swear' do not apply.
- 1.5 The Parties must make every reasonable effort to ensure they are free to view the Program with the other Party at prearranged times. Notice MUST be given at least 12 hours verbally or in writing before a scheduled viewing session if either Party finds they will be unable to view The Program. Otherwise, the offending Party will be subject to the penalty or penalties detailed below.
- 1.6 However, if there is agreement between both Parties, verbally or written, an amendment to this contract can be made, allowing one Party to watch one or more episodes of The Program without the other Party.

- 1.7 For any amendment to be made both Parties must be present and must be witnessed and countersigned by a neutral party. For the purposes of 1.7, pets do NOT count, even if they have human names.
- 1.8 The amendment will only cover the pre agreed episode or episodes of The Program and any further viewing will be viewed as a violation of the contract and the offending Party will be subject to the penalty or penalties detailed below. Allowing another episode of the Program to "auto-play" whether intentional or unintentional will be deemed as viewing of The Program in violation of the Dragon Pact and will result in penalty or penalties detailed below.
- 1.9 If either Party watches the final episode of the Program (the "Finale") without the other Viewer, the offending Party will be in breach of this contract and will result in the Finale Penalty detailed below, in addition to the other penalties detailed below.
- 1.10 If it is discovered that BOTH Parties have violated these terms the contract will be voided by general consensus and neither Party will be subject to penalty. As the contract is now void, both are free to watch the Program whenever and however they choose.

#### 2 Penalties.

- 2.1 The following penalties can be applied at will by the aggrieved Party and are in no way enforceable by law.
  - (i) The sustained ignoring or showing of interest in the violating Party for 24 hours (the "The Long Night");
  - (ii) Banishment from the living room until menial housework and tasks despised by others have been completed ("Joining the Night's Watch"); and/or
  - (iii) The aggrieved Party will be able, if they choose, to pursue action against the other Party through English Small Claims Court, the penalty being set

at one premium branded fizzy drink or small alcoholic beverage, and / or one Deliveroo item of their choosing at the next viewing session.

## **3** Finale Penalty.

- 3.1 The following penalty can be applied by the aggrieved Party at their discretion.
- 3.2 The aggrieved Party may establish a period of "**Shame**" onto the other Party, which will last until a new series of The Program is released and is available to view.
- 3.3 The period of Shame may be applied by either Party in conjunction with the Cold Shoulder and Taking the Black, and consists of
  - (i) Wear a burlap sack at all times, in place of clothing;
  - (ii) Be accompanied at all times, while in a public place, by a Nun ringing a hand bell, shouting the word "Shame" in ritual humiliation;
  - (iii) Display a generally shameful demeanour at all times.
